# **Annual Report April 2020 - March 2021**

#### PRESENTED BY THE CHAIRMAN

I am pleased to present the Annual Report of Kingston Parish Council for 2020/21 which tells you about the work of the Council over the previous year.

My thanks go to Cllr Roger Wetherell, the Vice-Chairman of Council, Cllr David Joyce, Chairman of the Finance and General Purposes Committee, Cllr Valerie Masson, Chairman of the Planning Committee, Cllr Karen Kenning, Cllr Peter Jolly, Cllr Keith Buckenham and Val Knight, Clerk of the Council for their support and hard work during the year.

I would also like to take this opportunity to thank County Cllr Roger Elkins and our District Councillors Cllrs Ricky Bower, Terry Chapman and Paul Kelly for their attendance at our Council meetings and their support on local issues.

The Annual Parish Meeting due to be held in May 2020 was cancelled due to the Coronavirus pandemic and all Council meetings held during the year were held remotely in accordance with Government guidelines. The year ended with the Coronavirus lockdown restrictions beginning to ease and we will return to holding meetings in Our Lady Star of the Sea Church Hall when social distancing rules and government advice allows.

## **OFFSHORE WIND FARM - Rampion 2**

In January 2021, Rampion 2 ran an informal consultation outlining their preliminary plans for an offshore Wind Farm along this coastline to add to the existing Rampion 1 scheme. Council raised some initial concerns and questions, summarised as:

- **Detrimental visual effect** given that the turbines would be only 8.1 miles from the shore; be taller than the Rampion 1 turbines (possibly 325m high); lit at night, and the combined span of Rampion 1 and 2 will affect the seascape of an extensive part of the Sussex coastline potentially from Newhaven to Selsey.
- Environmental Impact on birds as their safe flight corridors will be lost; on sea life as the seabed will be disturbed, and on the countryside and its wildlife when inshore cables are laid from Climping to Bolney.
- **Economic Impact:** how will the scheme affect the local economy including tourism and fishing?
- **Location**: Whilst Council fully supports the need to bring on stream more renewable energy, Wind Farms need to be located with sensitivity to the amenity and landscape of the local area. Are there other sites around the coast where the turbines can be set much further out to sea to reduce the visual impact?

The Council had virtual meetings with Rampion 2 and Protect Coastal England, the campaign group who are objecting to the proposal. To hear both sides of the argument and find out more visit their websites:

Consultation on a finalised scheme is expected to commence in July and Council will be considering the details of the scheme, and whether its concerns have been mitigated, very carefully when making its response. We encourage all residents to have their say on the proposals for Rampion 2 and respond to the consultation.

## HIGHWAYS AND FOOTPATHS

Our Winter Management Plan is still in place with County and but it only covers Kingston Lane (a public highway) and was not required this year as winter temperatures were quite mild and snow did not settle.

We continued to press for potholes to be filled and overhanging vegetation to be cleared. You can help: report problems at love.westsussex.gov.uk.

If you are responsible for hedges and trees along a road, please do **keep them cut back** so that they do not cause an obstruction or obscure visibility

#### **DRAINAGE**

It is still hoped that an application for funding from Operation Watershed (administered by County) to improve drainage in Peak Lane, will be made. However, during the year the details of the works proposed were revised by County and District and new quotes have been sought. In order to progress an application all affected landowners must have acknowledged Riparian ownership responsibilities.

All residents can help prevent flooding by ensuring that ditches on or abutting their property are kept clear with water running freely in the ditch.

#### FINANCE COMMITTEE

The Parish Precept is collected from residents with their Council Tax, and for 2020/21 was set at £9,000.

It is considered prudent to hold reserves so costs can be spread over several years. Costs during the year met from reserves and the Precept totalled £8,609 and included: Kingston Chapel Marker £1,443, a grant for St Marys Churchyard Maintenance of £350 and a grant towards the South Strand Community Toilets £300.

Balances at 31 March 2021 include reserves for: Environmental projects £2,559, Community involvement/newsletters £936. Parish elections £2.485. 30 years celebration of the Parish Council £492, Winter Management Plan £419, Neighbourhood Plan Review £4,788, Planning matters £2,000, IT equipment £92 and General Fund £12,422.

The Precept for 2021/22 has been set at £9,000 (no increase). The accounts will be formally considered by the Finance and General Purposes Committee when it meets on 5 May, 2021.

#### **POLICING**

**Crime Statistics** – PCSO Kate Houston provided the following statistics for the number of crimes recorded in the parish over a year for comparison: Year ending 28 February 2021: 16, Year ending 29 February 2020: 20, Year ending 28 February 2019: 11

PCSO Houston took over from PCSO Billingham during the year but in April 2021 will hand over to PCSO Rateiwa. Council wrote to the District Commander about the changes and he replied that there remains a commitment for consistency in terms of officers staying allocated to the same areas where possible.

#### LOST CHAPEL OF KINGSTON

A 2-ton natural boulder in the shape of a seat was unveiled by the Chairman on 4 September, 2020 on the West Kingston greensward. A plaque explains it marks where the old Chapel of Kingston was lost to the sea in C 1626. Council hopes that residents will enjoy sitting in this beautiful spot and remembering the Chapel.

#### **SEA DEFENCES**

We are concerned that local sea defences should be well maintained and continue to receive a copy of Arun's inspection reports so that we can monitor what works are being carried out and report problems.

#### REPRESENTATION

Council was represented at virtual meetings of the West Sussex Association of Local Councils. the South Strand Community Toilets Group and Rampion 2 Liaison Group.

The Chairman of Council laid a wreath at the Kingston War Memorial and the Vice-Chairman laid a wreath at the East Preston War Memorial on Remembrance Sunday.

### **EMERGENCY PLAN**

The last year has been dominated by the ongoing Coronavirus pandemic and having our Emergency Plan already in place was invaluable. We continued to inform residents on keeping up to date with government guidance and of help available to them, with Cllr Wetherell and Cllr Joyce on hand to give advice over the phone.

Our thanks to independent volunteer groups who helped residents in the parish.

## PLANNING COMMITTEE

The Planning Committee considered 23 planning applications during the year and we continue to refer to our Neighbourhood Plan.

#### Council made:

**No objection** to 19 applications although this was often subject to conditions being imposed e.g. obscure glazed windows. Arun granted planning permission for 18 of the applications (often with conditions reflecting the comments made by Council), with 1 undecided at year end.

**Objection** to 4 applications for reasons such as out of character to the surrounding area/intrusive to neighbours/in the Strategic Gap. Of the 4 that were objected to by Council, 3 were refused by Arun including a development in the Strategic Gap, with 1 undecided at year end

In October we met Sir Peter Bottomley MP to show him the rural setting of Kingston and discuss the effect indiscriminate building would have on Kingston. Sir Peter was sympathetic to our situation in regard to any large-scale house building in this area and we were encouraged by his interest to help us maintain our distinctive character and rural setting whilst avoiding coalescence with surrounding settlements due to building within the Gap.

### **FERRING RIFE**

Cllr Joyce has continued to regularly walk the Rife to ensure that any problems with the water flow can be reported to the Environment Agency promptly.

## MEETINGS AND COUNCILLORS April 2020 - March 2021

**MEETINGS:** During the year there were 6 Full Council meetings, 6 Finance and General Purposes Committee meetings and 6 Planning Committee meetings all held remotely due to the Coronavirus pandemic and the need for social distancing.

The Annual Parish Meeting was cancelled due to the Coronavirus pandemic although the Annual Report of Council for 2019/20 was prepared and published in the May 2020 newsletter.
