#### ELECTIONS 2023 - Please think about becoming a Parish Councillor

Parish Council elections are held every 4 years and the next election is in May 2023.

#### Is this for you?

There would be a commitment to attend full Council meetings which are held every 2 months and to attend meetings of the Planning and Finance and General Purposes Committee which meet on the same evening as Council and as required between Council meetings (say a further 4 meetings a year). There would also be the opportunity to represent Council on specific issues such as planning, policing, highways, resilience planning and biodiversity and to attend occasional meetings in connection with this.

There are seven councillors for Kingston plus the Clerk who is a paid employee of the council. The Council is funded by residents of the Parish in the form of a "precept" which it determines in its annual budget and is collected by Arun District Council as part of your council tax. Whilst there is a natural focus on parish issues and needs, it is also important to look at wider issues and policies which will impact on the parish e.g. from Government, County and District Council, and the Environment agency.

**Am I eligible? -** In order to be a Parish Councillor, you must:

- be aged 18 years or over and
- be a British citizen, or an eligible Commonwealth citizen or a citizen of a member state of the European Union.

You must meet at least one of the following on the day you are nominated and on polling day:

- be a local government elector in the parish (i.e. on the electoral roll) or
- have lived in the parish or within 3 miles of it for the last twelve months or
- have been an owner or tenant of any land or premises in the parish for the last twelve months or have your principal or only place of work in the parish

You do not have to belong to a political party.

**How do I stand for election?** - From around February 2023 you will be able to obtain a nomination paper from Arun District Council: check the Arun website nearer to that time https://www.arun.gov.uk/elections or ask the Clerk to keep you updated.

**Disqualification** - There are some factors which disqualify you for standing from election so you will need to check the nomination information carefully. #### SCHOOL ADMISSIONS 2023

County have advised that the application process for children to start in reception at primary and infant schools in September 2023, ends on 15 January, 2023. Children born between 1 September 2018 and 31 August 2019 are eligible to start school then and children who are currently in Year 2 at infant school will also need to apply for a place to start at junior school. #### RAMPION 2 OFFSHORE WIND FARM

Another public consultation has launched regarding the proposed Rampion 2 Project, that will run until the **29 November 2022.** This particular consultation is focusing on the onshore cable route alternatives that have been devised following the initial consultations in 2021. Council will be considering making comment on this consultation when it meets on 10 November, 2022.

The next expected application phase is that the owners of Rampion 2 have a finalised scheme and apply for a Development Consent Order to the Planning Inspectorate. At this point there will be further formal opportunity for Council and residents to make comment on the application.

#### Help with the rising Cost of Living

This is a difficult time for many households. Here is some information on finding the help that is available:

West Sussex County Council says it is working closely with district and borough councils and charities to support people and families who are struggling the most with the rising cost of living by using its Household Support Fund provided by the Government. Visit the County website:

- the 'Community Hub' that continues to offer direct support to vulnerable households, providing essentials such as food and supplies, as well as grants to those who are eligible.
- 36 West Sussex libraries offering a warm welcome to all visitors with staff on hand to help and advise on a range of topics, from money management to energy saving, job seeking and benefits guidance. Regular library events like Story Time are free for families of young children. East Preston Library is open from 1pm-5pm Monday, Tuesday and Wednesday and from 10am to 2 pm on Thursday, Friday and Saturday.

**Arun District Council** has a webpage with advice on: Council Tax and Benefits, Debt, Energy Bills, Broadband and phone packages, warmer homes and on accessing food banks. ### **Highways and Ditches**

The Community Winter Resilience Plan applies to Kingston Lane, the only public highway in Kingston. It provides the self-help salt bins that are in three locations along Kingston Lane (junction with Peak Lane and the two bends south of the junction with Elm Avenue). If you would like to volunteer to help with spreading the salt when the weather is cold, please contact the Clerk. There is also an arrangement with County for snow clearance to be carried out along the Lane by a contractor, when County agrees it is necessary (costs are shared).

With winter approaching please be aware that blocked **ditches** can cause flooding not just to nearby roads but perhaps more critically to homes. A riparian owner is the person with watercourses on, next to or under their property and they have the responsibility for maintenance. Please do check your ditches are clear of obstruction.

Overgrown hedges, trees and vegetation may cause a hazard for people using the adjacent highway by obstruction visibility. So, please ensure that yours do not overhang the highway in an unsafe manner and cut them back as a courtesy to others and to keep them safe. If the hedges, trees or vegetation overhang a public highway or verge and the local authority has to cut them back you may be recharged.

#### Be alert to potential Scams

Whilst there are many reputable trades people in the world it is worth keeping yourself up to date with latest scams whether they be from 'workers' cold calling at your house or phone calls allegedly from your bank or online emails or purchases or unexpected deliveries to your home or .... the list goes on!

**Trading Standards** officers are urging people to be on the alert for scams linked to the cost-of-living crisis and energy bills. They say 'If consumers receive emails or texts out of the blue, then report texts by texting 7726 (Ofcom), or forward emails to report@phishing.gov.uk and then delete the message'.

#### **Unauthorised Traveller Encampments**

You are probably well aware that during the summer there were several groups of travellers in the area that occupied a number of sites locally, including Goring Gap, Langmead's Field, the Rugby Club and Woodlands Park. There were also attempts to gain access to the Greenswards that were thwarted by the swift and decisive actions of residents, and followed up with measures taken by West Kingston Residents Association and Kingston Gorse Estate.

The police powers to act were revised in June 2022 and they are able to intervene where unauthorised encampments are causing environmental damage or distress to the community. See:

We do hope that the police make effective use of these powers to prevent a repeat of the problem next year for our parish and others in the area.

#### **Planning**

Council is very disappointed by recent Appeal decisions that have overridden the refusal of housing applications by District Council. Whilst not in our parish they will affect the A259 and other local infrastructure and impact on the character of the area. They are for 76 homes on land south of Littlehampton Road and east of Worthing Road (next to the junction of the A259, A280 and Old Worthing Road) and 191 homes on the Rustington Golf Centre site.

Council objected to both of these applications and has also objected to a current application for 70 homes at Lansdowne Nursery (north side of the A259).

For sites in Kingston and within the Strategic Gap, an application for stables and a barn was recently refused by District Council. This was on the same site as an application for a dwelling that was refused on Appeal.

We continue to work with other parishes to support each other in objecting to unsuitable developments.
