
Seeking a Judicial Review - Appeal for Funding

Re Planning Application for 47 dwellings land north-east of Kingston Lane (K/46/23/PL)

Further to our front page, item here is a recap of our letter last week and an update:

Firstly, a big thank you to many of you who have already donated (£5,845 raised as on 6 November)

Many of you objected to the above application, and it was obvious that this was a very emotive and important issue for both Kingston and neighbouring communities. We have contacted our neighbouring parishes asking for them to publicise this appeal for funding.



Access to the 47 dwellings will be from Kingston Lane on the first bend south of the junction with North Lane and representations were made to ADC about the hazards this will create. **The site is a much appreciated and beautiful area of countryside** visible from Kingston Lane and it sits within the Gap between Settlements (detailed in the Arun Local Plan). Importantly for sustainability, the development will result in the irreversible loss of Grade 1 agricultural land – that is the best and most excellent quality agricultural land.

450 objections were received by Arun District Council (ADC). Nevertheless, the application was approved conditionally by ADC on 20 March, 2024 and the final decision notice was issued on 27 September, 2024.

We took legal advice from a Barrister on potential grounds for Judicial Review (a legal remedy that can be used to challenge a local planning authority's decision in the High Court if there was an error in law). That advice highlighted an issue that could prove grounds for Judicial Review. If the Judicial Review is successful the ADC decision is "quashed". This means that the ADC would have to reconsider the matter. **It is important to note** that the outcome of this redetermination might be that the same decision will be reached. But it will allow the community to make further representation.

Based on the initial response to the fund raising, Council has asked our solicitor to proceed with the Application for Judicial Review that had to be made by 8 November, 2024. If the Court permits the application, the judicial review will proceed and further expenditure will then follow.

For Council to carry on with this process it therefore needs to urgently raise funds to cover future expenditure and potential costs that may be awarded. If the case is lost it could as an estimate be £35,000). We are hoping that this can be raised with contributions from <u>Kingston residents and residents of nearby communities who care about protecting this site</u>.

VOLUNTEER LITTER PICKING GROUP - Request from Cllr Richard Andrew

Hello.

I am hoping to help set up a Volunteer Litter Picking Group of residents to improve Kingston Lane and keep it clear of litter. This would operate independently of Council but would be eligible to apply for grants for equipment and protective clothing.

Kingston Lane, is the only adopted highway within the Parish and suffers, like many roads in West Sussex, with discarded litter. This is both unsightly and a hazard to wildlife. Arun District Council does not litter pick along here (although will clear any fly-tipping that is not on private land).

As a Member of Kingston Parish Council (KPC), I have raised this at meetings of Council, so Council has been aware of this for some time and has suggested that the first step is for me to try to establish the level of interest from Kingston residents in being involved in a one-off litter pick.

Once I have gauged whether there is sufficient demand, then an email group will be started in order to propose a date and make the necessary arrangements.

SCHOOL ADMISSIONS 2025

County have advised that the application process for children to start in reception at primary and infant schools in September 2025, ends on 15 January 2025.

Children born between 1 September 2020 and 31 August 2021 are eligible to start school then. Children currently in Year 2 at infant school will also need to apply for a place to start at junior school. The quickest way is to apply online:

Be Notified of Planning Applications Near You!

Did you know, that in January 2021, Arun District Council launched a planning application finder service?

You can use it to:

- search for planning applications submitted in the last 12 months near a property in the Arun district
- show the results in a list or on a map
- view the plans and comment on any of the current applications

The service also allows members of the public to sign up to **receive an automatic notification in their inbox** of any planning application submitted within a chosen radius of a postcode or address.

ROUNDSTONE CROSSING

East Preston Parish Council held a public meeting on the subject of the Roundstone Level Crossing on 12 July, 2024. You can read a report on the meeting in the East Preston Summer newsletter: https://eastpreston-pc.gov.uk/media/15626/east-preston-newsletter-no-71-summer-2024.pdf

One outcome was that the County Council repainted the white lines at the crossing and also decided to add a yellow grid box on the south side in front of the turn-out from North Lane. This to underline that those turning out from North Lane to go across the level crossing should give way to traffic on Worthing Road.

East Preston Parish Council have recently invited representatives from this Council and Angmering Parish Council to join with them to revisit the traffic management solutions first proposed to County in 2015.

The aim is to see if any of the proposals can be revised and considered by County now that the effects of works to improve the A259 (that were being planned in 2015) are known and also the impact of the additional development in the area can be assessed.

This Council is very aware of how frustrating it is to be held up at the crossing gates for so long and we still hope that, after so long, improvements (no matter how small) can finally be made.

POLICING

Crime Statistics – PCSO Raju sends regular updates to our Parish Council meetings. At our September meeting he reported that crime rate continues to be low in Kingston and that over the previous 2 months no crimes had been recorded.

Neighbourhood Policing Team (NPT) – Council and other Town/Parish Councils have regular invitations to attend online meetings with the NPT Inspector. These meetings are set to continue.

WINTER RESILIENCE PLAN

The Community Winter Resilience Plan applies to Kingston Lane - the only public highway in Kingston. It includes an arrangement with County for snow clearance to be carried out by a contractor, when County agrees it is necessary.

There are self-help salt bins in three locations along Kingston Lane (at the junction with Peak Lane and the two bends south of the junction with Elm Avenue). You are welcome to spread salt from the bins at each corner in a volunteer capacity

We would also appreciate regular volunteers coming forward to help with spreading salt when the weather is cold to pre-empt overnight ice on these sharp bends.
